To reclassify your Undetermined Residency, **this form must be turned in before the 30th calendar day of the quarter.** Failure to turn in this form before the deadline will result in Undetermined Residency reclassification being determined in the next quarter. *Submitting the Undetermined Residency form does not guarantee residency for tuition purposes.* Additional documentation or clarification may be required to determine whether you have met the requirements for residency for tuition purposes.
